EDUCATIONAL VALUES

Foundational Truth

At CMA, we believe that reverence and respect for the Lord is the beginning of wisdom. (Prov. 9:10) Our primary concern is the kind of person each student is becoming, over the mastery of particular skills. The knowledge of God, as found in the Bible, is the primary knowledge and the most important focus of our students and team. Without a strong relationship with the Lord, all the knowledge in the world will not lead to fulfillment.

Children are Persons (a Charlotte Mason philosophy)

Our curriculum is influenced by the belief that children are persons created in the image of God, not products. Every child is born with a thirst, ability, and desire to learn. Children are not a blank slate for the teacher to write upon, nor an empty sack for the teacher to fill; rather, they are a person who needs to be loved, informed, and instructed.

Learning for the sake of learning

We believe that the objective of the students should be to learn, not to win a prize or get an A. Effective learning occurs when the student wonders and seeks to know more, not merely asking if this topic will be on the test. Students are stimulated to observe, explore and understand. Our objective is to cultivate the students' inherent curiosity about the world around them and to urge them to do their best in every area. ([Galatians 6:4](#))

Arrival/ Drop Off Policy

- Please arrive promptly each day to allow students the opportunity to transition into their class and put away their bags.
- Students may be dropped off starting at 8:45am at the front of the building. An optional snack or breakfast can be provided by parent for student to eat, but it must be eaten prior to 9A.
- Parents are asked not to linger past 9A to not interfere with the morning routines.
- If you are tardy, students must enter quietly to not disturb Morning Assembly.

Dismissal

- If anyone, other than parent, is picking up students, our leads need to be made aware prior to pick up or students will not be released.
- If you need to pick up your child early, please inform our leads ahead of time to minimize classroom distractions.
- If you arrive earlier than 3PM, please remain in your vehicle until CMA has officially dismissed the students.
- CMA will be closed at 3:15P. We desire to be respectful to our teachers' home responsibilities, so we ask that the playground and field are not used after CMA hours without consideration of our teachers' time.

Attendance

We expect students to arrive at CMA on time and ready to learn with all of their needed supplies. If a child needs to miss class, please inform the teacher as soon as possible so make up work can be assembled and made available. Exceeded absences will result in the removal of CMA participation. CMA follows a 90% attendance rate for each student. **Students are required to attend church services regularly. If students are not in regular church attendance, it will result in the removal of CMA participation.**

CMA Closures

If we need to close CMA due to weather, sickness, or other complications we will communicate with parents by phone/text and the Discord app as soon as possible.

Payments & Fees

CMA payments are due within the first 5 days of each month. After this 5 day grace period, a \$25 late fee will be added per each student. Payments can be paid via check, cash, or Zelle. We ask parents to cover the processing fees associated with credit cards used online if using Tithely. Though Tithely is used for giving, because there is a transfer of services, program costs are not legally a gift, so cannot be counted as giving. There are no processing fees for checks, cash, or Zelle. For checks, please make payable to Christian Ministries Church. There will be no refunds once payments have been processed.

Cafeteria Information

Breakfast - Students can bring breakfast from home, if desired. Breakfast must be eaten at the table provided and needs to be finished by 8:55A.

Snacks - Please provide a snack for your child that can be eaten easily during a read-aloud/activity. Dry snacks are preferred. Snacks that require to be heated or utilize a utensil are not allowed.

Snack ideas: Veggie straws, a box of raisins, fresh fruit in a ziplock, popcorn, cheese stick, trail mix, granola bar, sliced apples, grapes, or beef jerky.

Lunch - CMA can only accommodate packed lunches at this time. Lunch is 12:30 - 1:00p.m. Students should bring their lunch in an insulated bag along with their water bottle, as mentioned in the school supply list.

Overflow - CMA offers a drink/snack café, which is open to the students after lunch and after school. The Overflow serves things such as chocolate milk, refreshers, strawberry lemonade, ice cream and various treats. Please discuss with your student(s) your personal family limits and expectations with the Overflow and notify teachers if you would not like for your child to place orders.

HEALTH AND EMERGENCIES

Administering Medicine

CMA will only administer medications that are approved by the parents on the “Medical Action Plan” document. If medication needs to be administered on a regular basis, CMA must have those medications with written instructions on how/when to use them.

Illness Policy

Any student with the following symptoms will be asked to stay home for 24 hours or picked up from CMA as soon as possible:

- * Fever of 100.5 F and above
- * Diarrhea
- * Vomiting
- * Nausea
- * Severe cough
- * Unusual yellow color to skin or eyes
- * Skin, eye lesions or rashes that are severe, weeping, or pus-filled
- * Difficulty breathing or wheezing
- * Complaints of severe pain
- * Thick, green mucus that continues to flow throughout the day

If your child is not feeling well in the morning, please observe them closely before sending them to CMA and risking the health of other students. If your child develops any of these symptoms while at CMA, you will be called immediately. If a child has mild symptoms, such as seasonal allergies, that do not impair their functionality, the child may remain in the classroom and the parent(s) notified when they pick up their child.

If your child is diagnosed with any communicable disease (chicken pox, whooping cough, fifth disease, pink eye, head lice, etc.) please report this to us as soon as possible. Students may return to school when released from the doctor with proper documentation.

Injuries and Medical Emergencies

If your child receives a mild injury while at CMA, we will promptly notify you. If a more serious injury occurs requiring immediate medical attention, parents and the emergency medical personnel will be notified immediately.

ACADEMICS/ OVERALL GROWTH

Curriculum

CMA's curriculum and philosophy of education are based on the works of Charlotte Mason, a 19th century British educator. Mason's philosophy and methods are based on her biblical worldview of children, families, God and education. A Charlotte Mason education includes first hand exposure to great and noble ideas through books in each subject, rather than rote memorization of dry facts. Besides books, students are exposed to great minds through art, music and poetry. Living books, rather than textbooks, are used to convey ideas that will engage the students and foster their love of learning.

Student Work and Evaluations

CMA encourages intrinsic motivation and a growth-oriented mindset which frees our students to develop a love of learning. In your typical American classroom, students engage in an assignment-work-completion routine, and in doing so, they develop habits of approaching work. Often the motivation is to finish the assignment at hand, get on to the next task, and do what is required to earn the desired grade. When students work with these ends in mind, they master the assignment-work-completion routine, and extrinsic system imposed by well-intended educators. The process, the act of work itself, takes on a secondary role. This system encourages them to develop habits aimed toward a good-enough outcome-at the expense of working well and doing their best.

CMA places the highest value upon daily interactions with each student, their own report of knowledge, comprehension, and critical thinking through narration, and student portfolios. Because of our teacher-to-student ratio, teachers have the benefit of knowing each child as a person and can monitor progress, set expectations, and develop lessons that are appropriate for each student. Narration (reflecting/communicating back what they understood) is used across subject areas, with each student narrating back a lesson or piece of literature. This provides students the ability to retain what they have learned through practical communication.

Leadership Requirements

Teachers at CMA must be born-again believers and actively engaged in the life of the church. All CMA teachers are passionate about our philosophy and pursue ongoing learning opportunities through conferences, books, and ongoing leadership training to strengthen their biblical worldview.

Standardized Testing

Although standardized testing is not our preferred method of assessment, we do not shy away from this process. Upon requests, CMA can administer the Stanford Achievement Test to students at the end of their seventh grade year. While these tests are not effective in measuring the full educational value of a student's growth in learning, they do offer a means for us to compare our students' progress in reading, math, and language skills with national norms. The test results will not affect the child's grade level placement. The parent has full freedom to opt-out from these tests if desired. PSAT/NMSQT will be offered when students are in the 11th grade to provide the opportunity for scholarships, if desired by the student or parent.

Discipline

Students at CMA are expected to come to CMA ready to learn and respond to the lead of the teacher. Our desire is to train students. Natural consequences are used as much as possible for inappropriate behavior. Here are a few examples:

- Sloppy work will result in them spending extra time correcting their work. Work needs to be done with their best effort, so if their best is not done, students will be asked to do it again or complete another assignment.
- Negative outburst will result in student missing class until the outburst is resolved. This could include missing a snack, recess/pe, delayed lunch, or suspension.

Disrespect toward any teacher or student will be addressed accordingly. If the student is continually being disrespectful and is not willing to change, then CMA administration has no other option than to remove the student from enrollment.

Our goal in every disciplinary situation is reconciliation and restoration, not separation and condemnation. Classroom interventions, a private conversation, jogging instead of playing outside, a meeting with parents and teacher are all strategies used in training our students. If a student is unresponsive to the teachers or administration, the child will be sent home. Consistent difficulties in discipline generates the discussion to determine whether the school/parent partnership is strong enough to continue to educate the child. CMA will not tolerate a student who is not willing to remain within the guidelines of CMA policy.

PARENTAL INVOLVEMENT/ STUDENT RESPONSIBILITIES

Parent's Role

CMA does not intend to replace the role of parental education and discipline; rather, we desire to walk alongside in the teaching and training of young minds. Our goal is to help equip and empower families to fulfill their God-given responsibilities as parents. Parental involvement is essential to CMA's discipleship model and we desire to keep communication open and consistent.

Enrichment Trips

We desire to extend learning beyond the walls of the classroom, provide opportunities for curriculum connections, and explore the wonderful places Houston has to offer. CMA will provide enrichment opportunities, in which parents can join in an outing. During these outings, parents are responsible for their individual child(ren) as well as snacks, restroom breaks, lunch, etc. These events are merely opportunities, and are not mandatory.

Cell Phone Policy

Cell phones or other electronic devices should be turned off and not be used while on church premises. If a parent needs to contact their child for any reason, please contact the Church office or a lead teacher. Any phones or electronic devices taken up during school hours will be kept by the teacher and can be picked up by the parents after dismissal.

Dating / Flirting

We desire to foster a wholesome family atmosphere, and in doing so, there can be an enormous amount of love and affection. As students grow and possibly become attracted to another student, we do not permit any dating throughout the entirety of their time at CMA. We do not shame a student for their God-given gifts of affection; rather, we attempt to not awaken love before its time. Flirting is defined as engaging in playful, suggestive communication or behavior that signals romantic, social, and at times sexual interest. Examples of flirting can be, but not limited to: playful touching, holding hands, kissing, verbal comments, and at times hugging. Not every moment of affection is flirting, so we desire to foster wholesome affection, while not crossing boundaries.

Birthday Celebrations

Birthdays are special occasions and are warmly celebrated at CMA. If you would like to bring a special treat for the class, please coordinate with the teacher ahead of time so we can take allergies into consideration. Please do not pass out birthday party invitations on CMA campus unless you are inviting the entire group.

Clothing Requirements

We desire for the students to be able to dress comfortably and in attire that is appropriate for a wide variety of activities. For younger students, soft pants with an elastic waist are best. For High School students, attire should be business casual. High School students should show up in a presentable fashion.

- Please refrain from sending your child to school with clothing that has fantasy, scary, secular artists, or super hero characters (i.e. Sponge Bob, Avengers, Star Wars, Kanye West, etc.)
- Students should wear tennis shoes, leather oxfords, crocs, or other shoes that firmly adhere to your child's foot. Please save cowboy boots, flip-flops, and rain boots for other "special" times.
